

NOTICE OF PROPOSED CLASS ACTION SETTLEMENT

Delgado v. Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center

Case No. 24CV08548

Superior Court for Siskiyou County, California

IF YOUR PRIVATE INFORMATION WAS DISCLOSED BY SISKIYOU HOSPITAL, INC., D/B/A FAIRCHILD MEDICAL CENTER, TO THIRD PARTIES WITHOUT AUTHORIZATION, A PROPOSED CLASS ACTION SETTLEMENT MAY AFFECT YOUR RIGHTS, AND ENTITLE YOU TO A CASH PAYMENT.

A court has authorized this notice. This is not a solicitation from a lawyer.

You are not being sued.

Please read this Notice carefully and completely.

- A Settlement has been reached with Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center (“Fairchild Medical Center” or “Defendant”) in a class action lawsuit. This lawsuit concerned Fairchild Medical Center’s use of third-party tracking technologies, called “tracking pixels,” on its web pages. The plaintiff claims that using tracking pixels violated certain privacy laws.
- The lawsuit is called *Delgado v. Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center*, Case No. 24CV08548. It is pending in the Superior Court for Siskiyou County, California (the “Litigation”).
- Fairchild Medical Center denies that it did anything wrong, and the Court has not decided who is right.
- The parties have agreed to settle the lawsuit (the “Settlement”) to avoid the costs and risks, disruptions, and uncertainties of continuing the Litigation.
- Fairchild Medical Center's records indicate that you are a Class Member, and entitled to benefits under the Settlement. You may have received a previous notice directly from Fairchild Medical Center.
- Your rights are affected whether you act or don’t act. ***Please read this Notice carefully and completely.***

Basic Information

1. Why was this Notice issued?

The Superior Court for Siskiyou County, California, authorized this Notice. You have a right to know about the proposed Settlement of this class action lawsuit, and about all of your options, before the Court decides whether to grant final approval of the Settlement. This Notice explains the lawsuit, your legal rights, what benefits are available, and who can receive them.

The lawsuit is called *Delgado v. Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center*, Case No. 24CV08548. It is pending in the Superior Court for Siskiyou County, California. The person that filed this lawsuit is called the “Plaintiff” (or “Class Representative”) and the company they sued, Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center, is called the “Defendant.”

2. What is this lawsuit about?

This lawsuit alleges that Fairchild Medical Center used third-party tracking technologies, called “tracking pixels,” on its website in a way that violates certain privacy laws. Fairchild Medical Center denies that it did anything wrong.

3. What is a class action?

In a class action, one or more individuals sue on behalf of other people with similar claims. These individuals are called the “Plaintiffs” or “Class Representatives.” Together, the people included in the class action are called a “Class” or “Class Members.” One court resolves the lawsuit for all Class Members, except for those who opt out from the settlement. In this Settlement, the Class Representative is Lori Delgado. Everyone included in this Action are the Class Members.

4. Why is there a Settlement?

The Court did not decide whether the Plaintiff or the Defendant are right. Both sides have agreed to a Settlement to avoid the costs and risks of a trial, and to allow the Class Members to receive benefits from the Settlement. The Plaintiff and their attorneys think the Settlement is best for all Class Members.

Who is in the Settlement?

5. Who is included in the Settlement?

The court has defined the Class this way: “All California citizens whose Private Information was disclosed by Defendant to third parties through the Meta Pixel and related technologies without authorization, which totals approximately 1,000 individuals.”

6. Are there exceptions to being included?

Yes. Excluded from the Class are: (1) the Judge in this case, and the Judge’s family and staff; (2) Fairchild Medical Center and its officers, directors, and related companies; (3) anyone who validly excludes themselves from the Settlement; (4) the legal representatives, successors or assigns of any such excluded persons; and (5) attorneys for the parties.

The Settlement Benefits

7. What does the Settlement provide?

All Settlement Class Members may enroll in a year or **CyEx Privacy Shield Pro** and/or claim the **cash payment** option. The benefits are explained in more detail below.

BENEFITS

CyEx Privacy Shield Pro. All Class Members are eligible to enroll in one year of CyEx Privacy Shield Pro. Enrollment codes have been sent to all Class Members by postcard. If you no longer have your enrollment code, please contact the Administrator.

This comprehensive service is designed to restore users' privacy and anonymity, and includes:

- Dark Web scanning
- compromised password scanning
- VPN, password manager, and other online privacy tools

If anything suspicious happens, you will be able to talk to a fraud resolution agent to help fix any problems.

Cash Payment. You may also claim a one-time cash payment. This payment is expected to be **\$25.00**.

You do not have to provide any proof or explanation to claim this payment.

8. What claims am I releasing if I stay in the Class?

If you stay in the class, you won't be able to be part of any other lawsuit against Fairchild Medical Center about the issues that this Settlement covers. The "Releases" section of the Settlement Agreement (Section 3) describes the legal claims that you give up if you remain in the Class. The Settlement Agreement is available at www.fairchilddatasettlement.com.

Submitting a Claim Form for a Settlement Payment

9. How do I submit a claim for a Settlement benefit?

The fastest way to submit your Claim Form is online at www.fairchilddatasettlement.com. If you prefer, you can download a printable Claim Form from the website and mail it to the Settlement Administrator at:

10. Are there any important Settlement payment deadlines?

If you are submitting a Claim Form online, you must do so by November 2, 2026. If you are submitting a claim by U.S. mail, the completed and signed Claim Form must be postmarked no later than November 2, 2026.

11. When will the Settlement benefits be issued?

The Court will hold a final approval hearing on October 15, 2026 (**see Question 18**). If the Court approves the Settlement, there may be appeals. We do not know if appeals will be filed, or how long it will take to resolve them if they are filed.

Settlement payments will be distributed if the Court grants final approval, and after any appeals are resolved.

The Lawyers Representing You

12. Do I have a lawyer in the case?

Yes, the Court has appointed law firms CohenMalad LLP; Stranch, Jennings & Garvey PLLC; and Strauss Borrelli, PLLC, to represent you and other Class Members ("Class Counsel").

13. Should I get my own lawyer?

You will not be charged for Class Counsel's services. If you want your own lawyer, you may hire one at your expense.

14. How will Class Counsel be paid?

Class Counsel will ask the court to approve \$100,000.00 as reasonable attorneys' fees and reimbursement of litigation costs. This amount will be paid by Fairchild Medical Center.

Class Counsel will also ask for a Service Award Payment of \$2,500.00 for the Class Representative. The Service Award Payment will also be paid by Fairchild Medical Center.

Excluding Yourself from the Settlement

15. How do I opt out of the Settlement?

If you do not want to be part of the Settlement, you must formally exclude yourself from the Settlement. This is called a Request for Exclusion, and is sometimes also called "opting out." If you opt out, you will not receive Settlement benefits or payment. However, you will keep any rights you may have to sue Fairchild Medical Center on your own about the legal issues in this case.

If you exclude yourself, you are telling the Court that you do not want to be part of the Settlement. You will not be eligible to receive any Settlement benefits if you exclude yourself.

The deadline to exclude yourself from the Settlement is September 28, 2026.

To be valid, your Request for Exclusion must have the following information:

- (1) the name of the Litigation: *Delgado v. Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center*, Case No. 24CV08548, pending in the Superior Court for Siskiyou County, California;
- (2) your full name, mailing address, telephone number, and email address;
- (3) personal signature; and
- (4) the words "Request for Exclusion" or a clear and similar statement that you do not want to participate in the Settlement.

You may only exclude yourself—not any other person.

Your Request for Exclusion must be submitted, postmarked, or emailed by September 28, 2026.

Commenting on or Objecting to the Settlement

16. How do I tell the Court if I like or do not like the Settlement?

If you are a Class Member and do not like part or all of the Settlement, you can object to it. Objecting means telling the Court your reasons for why you think the Court should not approve the Settlement. The Court will consider your views.

You cannot object if you have excluded yourself from the Settlement (**see Question 15**). However, if you object and the Court overrules your objection, you will be given an additional opportunity to opt-out of the Settlement.

You must provide the following information for the Court to consider your objection:

- (1) the name of the Litigation: *Delgado v. Siskiyou Hospital, Inc. d/b/a Fairchild Medical Center*, Case No. 24CV08548, pending in the Superior Court for Siskiyou County, California;
- (2) your full name, mailing address, telephone number, and email address;
- (3) information that proves that you are a Class Member (such as a notice you have received);
- (4) a clear description of all the reasons you object; include any legal support, such as documents, you may have for your objection;
- (5) if you have hired your own lawyer to represent you for this objection, provide their name, bar number, and contact information;
- (6) whether or not you or your lawyer would like to speak at the Final Approval Hearing;
- (7) if you or your lawyer have objected in any other cases in the past three years, list the names, courts, and civil action numbers for each of those cases; and
- (8) your signature (or, if you have hired your own lawyer, your lawyer's signature).

For your objection to be valid, it must meet each of these requirements.

To be considered by the Court, you must file your complete objection with the Clerk of Court by September 28, 2026. You must also send a copy of the objection to the Settlement Administrator, Class Counsel, and counsel for Defendants.

17. What is the difference between objecting and excluding?

Objecting is telling the Court that you do not like something about the Settlement. You can object to the Settlement only if you do not exclude yourself from the Settlement. Excluding yourself from the Settlement is opting out and stating to the Court that you do not want to be part of the Settlement. If you opt out of the Settlement, you cannot object to it because the Settlement no longer affects you. If you object and the Court overrules your objection, you will be given an additional opportunity to opt-out of the Settlement.

The Court's Final Approval Hearing

18. When is the Court's Final Approval Hearing?

The Court will hold a final approval on **October 15, 2026 at 9:30 a.m. Pacific Time**, in the courtroom of the Honorable Kendall Hannon located in the Civil Division of the Superior Court of California, County of Siskiyou, 411 Fourth Street, Yreka, CA 96097.

At the final approval hearing, the Court will decide whether to approve the Settlement. The court will also decide how Class Counsel should be paid, and whether to award a Service Award Payment to the Class Representative. The Court will also consider any objections to the Settlement.

If you are a Class Member, you or your lawyer may ask permission to speak at the hearing at your own cost (**See Question 16**).

The date and time of this hearing may change without further notice. Please check www.fairchilddatasettlement.com for updates.

19. Do I have to come to the Final Approval Hearing?

No. Class Counsel will answer any questions the Court may have. You may attend at your own expense if you wish, but you do not have to.

If you file an objection, you do not have to come to the Final Approval Hearing to talk about it; the Court will consider it as long as it was filed on time. You may also pay your own lawyer to attend, but you do not have to.

If I Do Nothing

20. What happens if I do nothing at all?

If you do nothing, you will not receive a benefit from this Settlement.

You will also give up the rights described in **Question 8**.
